Family Support – Offering crisis intervention and support to families. Supporting older adults and their caregivers to create a plan for the future.

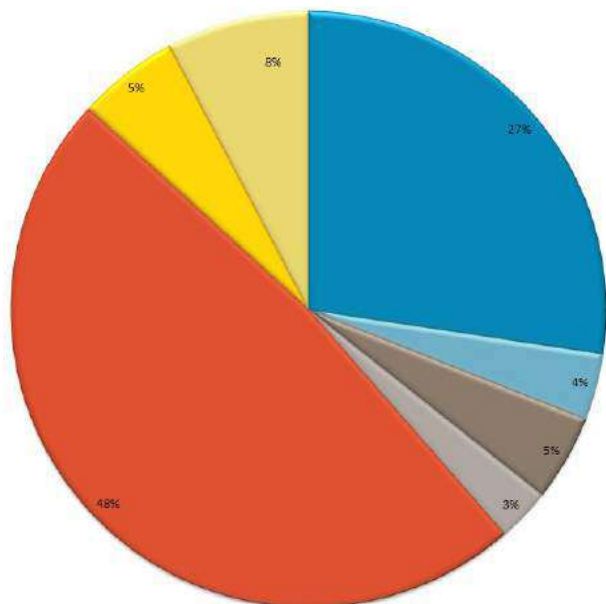

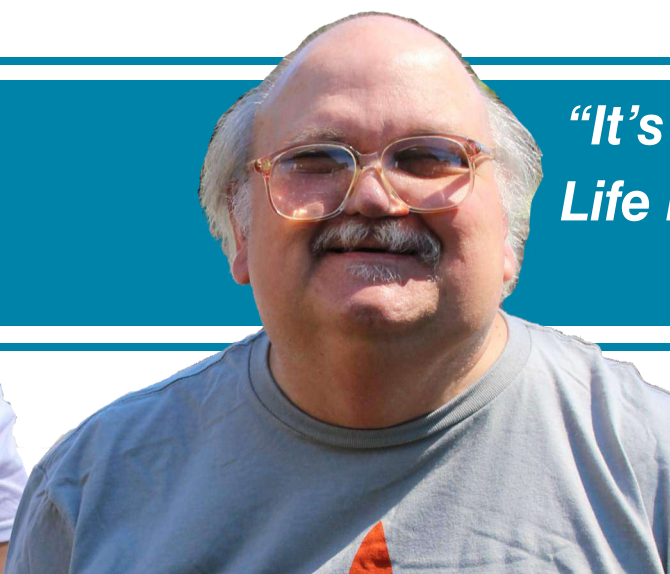
