Fee Schedule**

**Life Navigators:**

**Establishment Fee:** Life Navigators charges an establishment fee of \$400.00 for the Trust I – Community Trust, Trust II – Pooled Trust and Trust III – Pooled Trust For Age 65 and older. The fee must be received by Life Navigators at the time the Instrument of Adoption is signed.

The Establishment Fee includes file set up and administration and a personalized assessment. When an Instrument of Adoption is completed, Life Navigators staff will arrange to meet with the Settlor(s) for the purpose of gathering information about the Beneficiary and the Settlor's intentions regarding the use of the Trust for the Beneficiary. Access to the Life Navigators team is on an ongoing basis to provide assistance in identifying resources and planning for the future.

**Monthly Trust Manager Fees:** In its role as Trust Manager, Life Navigators will ensure distributions are for the sole benefit for the beneficiary to ensure their needs and desires are met. Additionally, Life Navigators will inform the Trustee, Prairie Trust, with regard to the Beneficiary's qualification for government benefits and the effect that any distribution (payment) from the trust will have on the Beneficiary's qualification for government benefits. The monthly fee for funded trusts is based on the market value of each trust, determined at the end of the preceding month. The fee shall be deducted from each individual trust as follows:

<b><u>Account Size</u></b>	<b><u>Life Navigators Monthly Fee</u></b>
Under \$25,000	\$35.00
\$25,001 - \$50,000	\$50.00
\$50,001 - \$150,000	\$80.00
\$150,001 and above	0.70% of Trust Assets/Annualized

**Advisor Fees:** Life Navigators may charge fees when serving as a Professional Advisor to Prairie Trust, a division of Waukesha State Bank. When monthly services provided exceed 2 hours per month to ensure the beneficiary's needs and desires are met, Life Navigators may bill the trust at \$72.00 per hour. When the monthly services provided include travel to meet the beneficiary's needs, Life Navigators may bill the trust for travel time and mileage reimbursement at the rate established by the Internal Revenue Service.

Life Navigators may also be designated by the Settlor to serve as the Personal Needs Advisor. In this role, Life Navigators will communicate with the Trustee in regard to the Beneficiary's needs and desires from a personal standpoint to guide the Trustee in making distributions. If families choose to contract with Life Navigators, the current fee for Personal Needs Advisor services is \$72.00 per hour. When the monthly services provided include travel to meet the beneficiary's needs, Life Navigators may bill the trust at the rate established by the Internal Revenue Service.

Life Navigators reserves the right to revise fees at any time. If needed, based on individual financial need, Life Navigators will waive fees and/or make alternative financial arrangements.

**Early Termination Fee:** Life Navigators will charge a \$400 early termination fee for any trust terminating within one year of final signature date.

**Services:**

- Assign a dedicated personal trust administrator and portfolio manager to each account
- Personalized investment policy statement developed through a comprehensive review of financial objectives
- Bill payment and disbursement processing
- Work with Life Navigators on discretionary decision-making issues
- Collection, custody, and safe keeping of trust assets
- Securities settlement and cash processing
- Retain trust information
- Provide quarterly and annual statements to beneficiaries or designee

**Monthly Fees:** The fee for funded trusts is a base fee plus a fee on the market value if trust assets total \$50,000 or greater. Fees are charged on a monthly basis with market value fees determined at the end of the preceding month.

<u>Account Size</u>	<u>Prairie Trust Monthly Fee</u>
Under \$25,000	\$12.50
\$25,001 - \$49,999	\$25.00
\$50,000 - \$399,999	\$25.00 plus 0.85% annualized
Value in excess of \$400,000	\$25.00 plus 0.85% annualized on the first \$399,999 plus 0.65% annualized on the balance

**Other Fees:**

- \$20 fee per wire transfer
- \$25 reissuance fee for uncashed checks greater than 90 days old (stale checks)
- \$400 termination fee
- \$100 class action litigation processing fee if Prairie Trust is no longer custodian of trust assets at the time proceeds are received
- \$400 per trust tax return (Trust I); \$200 per 1099 (Trust II and Trust III)
- \$250 Motor Vehicle lien set-up fee; \$250 Motor Vehicle lien release fee
- Additional reasonable fees for complex matters including but not limited to administration of real estate and trust and estate settlement

**Investment of Assets:**

<u>Account Size</u>	<u>Investment Strategy</u>
Trust II and Trust III <\$10,000	Uninvested Cash <sup>1</sup>
Trust I <\$10,000	Money Market Cash
All trusts \$10,001 - \$50,000	Single Moderate Allocation Mutual Fund
All trusts >\$50,000	Asset Allocation Model Managed by Prairie Trust <sup>2</sup>

<sup>1</sup> A 1099 is required to be filed for \$10 or more of income generated within a first party trust. Accounts with balances less than \$10,000 will not generate enough interest income to pay the \$200 tax preparation fee. Therefore, we hold these assets in uninvested cash.

<sup>2</sup> We will work with family members or appropriate interested parties to determine the most appropriate asset allocation for each account.
