For beginners, it can assist in determining their potential to become independent drivers. The evaluation includes clinical pre-driver screening and behind-the-wheel assessment.

Devices are available for demonstration, loan or sale and include amplified phones, flashing doorbells, smoke alarms and TTY's. CAP can assist individuals and their advocates by providing information about what the agencies can and cannot do and by providing suggestions on how to resolve complaints. If an individual has been denied service, CAP can assist with the appeal process, including representing the individual in the hearing. CAP will also provide legal remedy assistance in cases where the state Vocational Rehabilitation agency has violated the Federal Rehabilitation Act.
